You are cordially invited to attend the 2002 Executive Safety Summit December 3-4, 2002, at the Westfields Marriott Conference Center in Chantilly, Virginia (near Washington Dulles Airport). Pre-registration will begin on the evening of December 2; dinner will be provided for those who pre-register. Wrap-up of the summit will be at 3:30 p.m. on December 4. Attendance at this conference is limited to you and one additional invitee of your choice. This invitee may be a senior manager, individual, or union officer who may contribute to, or gain practical insight from, the conference. For contractor invitees, you are also encouraged to invite a corporate manager from your parent company.

The agenda is being finalized and will be forwarded to you prior to the summit. The first day of the summit will focus on sharing our accomplishments and progress in safety management in the year 2002. Our safety initiative champions and selected line managers will share successes and best practices in the plenary session, and the Secretary is invited to observe this portion of the program and share his comments and outlook at the luncheon. Additional features of the first day will be a video on safely accomplishing DOE missions, external speakers on the successful integration of mission and safety, and an evening reception with a best practices poster session.

The second day will focus on the path forward to institutionalize many of the safety strategies and initiatives, and identifying additional barriers. This day will also feature presentations on the best practices winning posters by the responsible senior managers. We will wrap up the conference with a panel of Assistant Secretaries/Program Office Directors who will address application of safety management initiatives, best practices, and Integrated Management to unique programs, mission, and activities.
